Workshop sessions

Delegates will have the opportunity to attend **2 out of the 6** workshops.

All workshops are run both morning and evening.

Workshop 1:

Care of Elderly
Workshop description Falls are a major cause of patient morbidity and mortality, and falls prevention is a key healthcare priority. Our workshop will focus on identifying and deprescribing Fall-Risk Increasing Drugs (FRIDs), as a strategy to reduce falls risk. In addition, optimising bone health medication, to reduce the risk of serious injury from falls, will be addressed. The second part of our workshop will provide participants with the opportunity to work on falls-related case studies, and learn how to prioritise FRIDs for deprescribing, and optimise bone health medication, in order to reduce risk of injurious falls.
Learning objectives <ul style="list-style-type: none">• Identify medicines which can place the person at increased risk of falls (using a variety of tools such as STOPPFalls, and assessments of anticholinergic burden).• Prioritise medicines to stop/reduce/change to safer alternatives via medication review.• Use of the Fracture Risk Assessment (FRAX) Tool to evaluate the probability of bone fracture risk and to identify patients who may benefit from bone protection• Understand Bone Health Medication treatment options

Workshop 2:

Patient-centred pharmacotherapy optimisation in frail older adults with limited life expectancy
Workshop description This workshop focuses on recognising frailty in older adults, rationalising medications using validated tools and clinical judgement, managing the deprescribing process, and evaluating the outcomes.
Content and Structure: 1. Introduction [5 minutes]:

- Explanation of workshop aims and learning outcomes, and interactive icebreaker to assess participants' challenges in this area.
2. Outline of evidence and key principles [20 minutes]:
 - Factors that must be considered when aiming to optimise pharmacotherapy in frail older adults - such as remaining life expectancy, goals of treatment, medications' time-to-benefit, administration issues, and withdrawal complications.
 - A description of the key principles, tools, benefits, and challenges with deprescribing in frail older adults.
 3. Small-group activity [35 minutes]:
 - Short clinical cases based on real-life patients for participants to discuss and collaboratively identify medication issues, followed by generation of treatment plans.
 4. Feedback on cases and plenary discussion [40 minutes]:
 - Discussion of group-generated recommendations from the patient cases.
 - Good practices with deprescribing interventions and overcoming associated challenges.
 5. Conclusion [5 minutes]:
 - Providing take-home messages to help participants plan the next steps in improving the quality of pharmacotherapy of frail older adults in their practice.

Learning Objectives:

Regarding frail multimorbid older adults, this workshop will help participants:

- Gain a greater understanding of how to take a patient-centred approach in medication optimisation with limited life expectancy.
- Apply key principles and validated screening tools (e.g. STOPPFrail) in identifying medication-related problems and managing opportunities for deprescribing.
- Critically evaluate and discuss complex patient cases.
- Collaboratively develop medication recommendations and monitoring requirements.
- Manage possible challenges with deprescribing (e.g. adverse drug withdrawal effects) and measure the outcomes of deprescribing.

Workshop 4:

Management Workshop – Interviewing Skills – The key to hiring

Aim of workshop / Brief description

The course recognises that interviews are 2-way processes and in order to make effective hiring decisions, interviewers need the required skills to make sound recruitment decisions. The programme will provide essential skills to people managers to improve their confidence and competence when involved in the recruitment & interview process. Through discussion the group will draw on their own experiences of being both sides of the interview table and reflect on good practice in order to enhance their own existing skills.

Learning objectives:

Provided on the day

- “Re-fresh” core skills involved in interviewing to build confidence, which in turn will ensure that candidates are put at ease so that they can do their best to represent themselves to the panel.
- Review & briefly practice probing competency-based interviewing methods to “get past” the 1st glossy answer often presented by candidates.
- Understand relevant elements of the HSE interview process, specifically the need to be fair and consistent in approach with individual candidates.
- Understand the need to be adequately prepared, including reviewing all relevant paperwork and planning the questions to ask.

Workshop 6:

EAHP Academy Seminar feedback: Qualitative Research Methods

Workshop description

In 2019, the European Association of Hospital Pharmacists (EAHP) held a 2 day seminar on Qualitative Research Methods.

EAHP Academy Seminar description: “What is qualitative research? Why is it used? How is it performed? When we evaluate hospital pharmacy services or develop new ones, what do we need qualitative research for? Qualitative research aims to answer the questions what, how and why. What do patients think of their medicines? Why patients do not use their medicines as intended? How do they take them instead and why? Qualitative research can be used on its own or alongside quantitative research to answer research questions. A multitude of different qualitative methods and approaches to qualitative analysis exist and it is important to know their advantages and disadvantages to select the most appropriate for a certain health services or pharmacy practice research question.”

This workshop will apply the methodologies outlined in the seminar by focusing on: “What is qualitative research? Why is it used? How is it performed?”

Learning objectives:

- Explain what qualitative research is and why it should be used.
- Formulate qualitative research questions and prepare topic guides.
- Apply methods used in qualitative interviews, including focus groups.
