The successful applicant will be responsible for:

- Ensuring the purchase, storage and supply of all medicinal products is operated safely, appropriately and economically, consistent with quality at pharmacy, ward and department levels and with reference to clinical appropriateness.
- The supervision, development and monitoring of the clinical pharmacy services.
- Promoting safe medication management practices within the dispensary and in the wider hospital and effectively managing risk to facilitate continuous improvement in the medicines management process.
- Providing advice and education to Nursing and Medical staff on the proper, safe and economic use of drugs including participation in initiatives for the dissemination of information.
- Liaising with Pharmacy, Nursing, Medical, other relevant stakeholders including the Quality and Risk Department to ensure safe standardised medicines management processes and to implement quality improvement initiatives
